## Location

The property is located on New York Way within the well-established New York Industrial Estate. The property is 0.5 miles from the Silverlink junction of the A19 and A1058 (Coast Road) with the Tyne Tunnel 1.5 miles to the south. Newcastle City Centre is 7 miles to the west.

## Description

A semidetached industrial unit constructed in 1997, comprising a steel portal frame, full height brick elevations and a pitched roof of insulated profile metal sheeting incorporating translucent roof lights.

The property has extensive offices and amenity space provided over two storeys at the front of the building. The offices have gas central heating, LED lighting and furniture is available by way of separate negotiation.

The warehouse has LED lighting, gas warm air blowers and access is via a sectional insulated up and over loading door measuring 3.5m wide by 4.3m high.
