Location

Foxcover Distribution Park is on the south side of Seaham, 1.5 miles east of the A19 via the A182. It lies approximately 12 miles east of Durham, 20 miles south east of Newcastle upon Tyne and 25 miles north of Middlesbrough, providing good access to all the whole North East region. Access to the properties is via Admiralty Way, with other occupiers including Panther Logistics, Lineage Logistics and Biffa.

Description

This detached industrial warehouse was built in 2007 and comprises steel portal frame construction, with insulated profile sheeting envelope. Loading access is via 2 self-levelling dock loading doors and one level access insulated up and over door. There is provision for a further two dock levellers if required. Secure car parking and service yard area is provided to the front. The property has a minimum internal eaves height of 10m and floor loading capacity of 50KN/m2. Internally the unit benefits from a reception area, office accommodation with raised access floor and suspended ceilings and male/ female/ disabled WC's.
