Location

The property is located on the Spectrum Business Park. The estate lies approximately 15 miles south east of Newcastle upon Tyne, 10 miles east of Durham and approximately 20 miles from Teesside, benefitting from excellent access to the A19 and wider regional road network.


The unit is accessed from the A182 which gives direct access to A19.

Description

The property comprises a semi-detached double unit of steel portal frame construction with composite wall cladding over cavity brickwork to the elevations under a pitched profile metal clad roof. The unit has a minimum eaves height of 5.5m m to the underside of the haunch and a maximum apex height of 7m. The warehouse is accessed via two electric roller shutter doors which measures 4m wide by 3.8m high.

Internally the unit benefits from a concrete floor and LED lighting. To the front elevation of the unit are two loading doors. Offices are incorporated at ground floor with a mezzanine storage area above.

The unit also benefits from kitchen facilities and male and female WCs.
